## ATA 542 SOCIAL HISTORY OF REPUBLICAN ART AND LITERATURE Fall 2014

The course will run as a seminar where each week students are expected to present the major questions rising up in their readings. The purpose is not to summarize but to take a critical stance with regard to the readings. Participation in class discussions is required and is an important portion of the final grade. The course grade will be given in the following manner: Midterm I (20 %), Midterm II 2 (25%), Paper (30%), Reading reports, participation, attendance and presentations (25 %). The paper is expected to be 12-15 pages. Detailed information about the paper will be provided. The reading reports should be between 1-2 pages. All written work should be typed with reasonable spacing and paragraphing and turned in as a hard copy.

In other words, it should <u>not</u> be a summary of your readings but should consist of your own ideas with regard to these readings. Therefore it should <u>not</u> contain long quotations. Your discussion should give specific references to the readings when necessary. Please pay attention that your ideas follow each other logically and coherently in your analysis.
